6. The defendant is prohibited from taking, converting or damaging property in which the plaintiff may have legal interest; and

- 7. The plaintiff is awarded temporary sole parental rights and responsibilities of the following minor child(ren) residing in the household (List names and dates of birth):
- 8. The defendant is prohibited from possessing any firearm and any dangerous weapon(s) described in the attached Order Prohibiting Possession and Requiring Relinquishment of Firearms and Weapons dated

Protection from Harassment cases only:

- 9. Plaintiff has provided the defendant with notice that plaintiff is seeking a temporary order.
- 10. The court finds that it would not be reasonable to require the plaintiff to provide defendant with notice that the plaintiff is seeking a temporary order \Box Due to the nature of the alleged conduct \Box Other \Box .

This Order is effective forthwith and will remain in effect until terminated by service of a final protection order, by entry of a modified temporary order, or by entry of an order vacating this temporary order.
