Native American Issues:

Office of State-Tribal Relations: This bill would have created a new Office of State-Tribal Relations within the governor's office. The bill was approved by the Senate but died when it was not voted upon by the House of Representatives.

Private Land Deer Permits: This bill requires the Department of Environmental Protection to issue, with no fee, private land deer permits to Indians to hunt on their Tribe's reservation lands. The reservation must be at least 250 acres for members to be eligible. The permit allows them to hunt deer from November 1 through December 31 using a rifle, shotgun, muzzleloader, or bow and arrow. Currently, Indians may hunt on their reservation lands without a license under the same regulations and during the same hunting season as licensed hunters generally. This bill passed and has been signed into law.

Welfare Issues:

Public Act 00-2 was passed during the Special Session of the Legislature this June. The bill was designed to set the budget for the Department of Social Services. However, the bill also included some major changes in welfare policy. These include:

Security Deposit Guarantee Program:

Before the change, people getting cash benefits (such as temporary family assistance or general assistance) and living in emergency housing were entitled to get a cash security deposit to help them move into permanent housing. This law has been changed. People in this situation are now eligible only for a guarantee that DSS will pay a security deposit to the landlord instead of having DSS make a cash payment directly to the landlord. Cash payments can still be paid in very limited cases, but only if there is money available in the state's safety net account. If you: (a) get cash benefits; (b) are living in emergency housing; (c) cannot live in

permanent housing for a number of listed reasons; and (d) are faced with emergency circumstances which threaten the health, safety or welfare of a child living with you, you may be eligible for a cash payment to your landlord for one month's rent.

Prior Authorization for Prescriptions:

DSS has been given the authority to issue regulations that will require prior authorization for certain drugs covered by Medicaid, state-administered general assistance, general assistance, or the ConnPACE program. This means that you will be unable to get these prescriptions unless you or your doctor has gotten prior approval from an independent pharmacy consultant authorized by DSS. The drugs that are affected by the program are any first prescription for a drug costing over \$500 for a thirty day supply and any early refill of any drug covered by these programs. This bill is expected to make it harder for doctors to prescribe brand-name drugs instead of generic drugs.



Bureau of Indian Affairs Issues Proposed Findings Supporting Federal Recognition for Eastern Pequots and Paucatuck Eastern

On March 31, 2000, the Assistant Secretary - Indian Affairs published Proposed Findings in the Federal Register. These Findings recommended granting the Petitions for Federal Recognition filed by both the Eastern Pequots and the Paucatuck Eastern Pequots.

Pequots

In both Proposed Findings, which are identical in many areas, the Assistant Secretary stated that there was not enough evidence in the record at the time the Findings were issued to decide whether the two Tribes were in fact a single Tribe after 1973 or whether they were two separate communities. The Assistant Secretary did find that, whether there was one Tribe or two, there was enough evidence to give federal recognition. In reaching this conclusion, the Secretary placed great weight on the fact that the Eastern Pequots at the Lantern Hill Reservation had been recognized by the State of Connecticut since colonial times. The Tribes and other interested parties were invited to provide more evidence during the comment period on the question of whether there were in fact two separate Tribes.

Under Bureau of Indian Affairs regulations, there is a comment period that runs for 180 days after the date on which the Proposed Findings are published in the Federal Register. No final decision will be issued until the comment period has ended. The towns of Ledyard, Preston and North Stonington are contesting the proposed findings.



Statewide Legal Services

Call Statewide Legal Services of Connecticut, Inc. (SLS) if you are low income and believe you have a legal problem. It

is a toll-free telephone hotline that can give you free help in the following areas:

If you meet income eligibility standards, SLS can help you as follows:

- ▶ Problems that can be settled quickly. SLS staff can handle some of these problems themselves. example, SLS staff can call your local General Assistance office to explain a mistake.
- More complicated problems. SLS can refer you to one of the four legal service agencies in Connecticut, a law school clinic, a specialized legal services agency, or a pro bono (free) lawyer. SLS makes referrals based on its priorities and resource limitations.
- ▶ Problems you can handle yourself. SLS can give you telephone instruction, send you written materials, or tell you about classes to help you represent yourself.
- Non-priority problems. If you have a problem which cannot be accepted by SLS or a referral agency, SLS can give you general advice.

Pine Tree operates a special Native American Unit in its Bangor, Maine office. The unit is staffed by attorney Craig Sanborn and is headed by Eric Nelson. Craig is a member of the Penobscot Nation. He joined the Pine Tree Staff in September of 1998 Eric has worked at Pine Tree for many years on behalf of migrant farmworkers and Native Americans.

Pine Tree attorneys are not licensed to practice law in Connecticut. However, the Native American Unit may be able to give information and help to low-income Native Americans in Connecticut with federal legal problems, such as questions about the Indian Child Welfare Act and the Jay Treaty. Pine Tree can also refer cases to lawyers in Connecticut. The telephone number is 1-800-879-7463.

Free Help For Tax Problems

If you are a low income tax payer facing an audit, an administrative appeal, or litigation about your state or federal taxes, you may be



eligible for free legal help. Quinnipiac College School of Law Legal Clinic (203-287-3238) and UCONN School of Law Tax Clinic (860-570-5165) offer free clinics to help with tax problems. They can give you free advice about your rights and free income tax preparation. All consultations are free and all

information is confidential. Income limits apply.

You May Qualify for Medicaid, Even if You Don't Get Cash Assistance

You no longer need to be eligible for cash assistance in order to be eligible for Medicaid. This separation between eligibility for cash benefits and Medicaid is called "delinking." means that families who lose or never received cash assistance may be eligible for Medicaid.

States are now required to take steps to identify who may have been wrongly terminated and to reinstate those In Connecticut, the Department of Social Services is trying to identify families that have been wrongly terminated from Medicaid since October 1, Families that were incorrectly terminated or incorrectly denied Medicaid will be reimbursed by DSS for their out-of-pocket medical costs. DSS will also reimburse providers for a family's outstanding bills.

If you lost Medicaid since October 1, 1996 and either paid for medical care or still owe medical bills, call DSS to find out if you may have been wrongly dropped from the Medicaid program. You can also call Statewide Legal Services at 1-800-453-3320 or 860-344-0380.
